**Reciprocity** – Form used for individuals that hold certification from ISAC or Pro Board. Basically, it used to transfer the information onto our database, if we hold that level of certification. An individual that is requesting reciprocity from an ISAC certification a Pro Board application will be issued. However, if an individual is requesting reciprocity from a Pro Board certification, the individual will not receive another Pro Board application. The information will only be transferred onto our database, because they already hold a Pro Board certification for that identified level.
